AVETMI SS Release 7.0

Introduction

The AVETMIS Standard for VET Providers has been reviewed and updated to reflect current changes in the VET sector. Several major initiatives have been incorporated into this new release. AVETMISS Release 7.0 will come into effect for training activity (2014) data submissions from **1 January 2014**.

The details for *Release 7.0 of the AVETMIS Standard are indicated in blue font* and the *Queensland Specific Requirements are indicated in maroon font* – both changes are contained within this document.

Summary of changes

The following is a summary of the changes from AVETMISS Release 6.1 to Release 7.0, additional state reporting requirements and the data files in which they occur. Please refer to '<u>File Structures'</u> for new file layouts.

Validation rules

Validation rules have been added to the Enrolment (NAT00120) and Program Completed (NAT00130) files.

- 1. Two rules regarding **Activity Start Date** and **Activity End Date** fields have been added to the Enrolment (NAT00120) file:
 - "Activity Start Date must NOT be more than 5 years prior to collection year"
 - "Activity End Date must NOT be more than 5 years after Activity Start Date".
- 2. One rule regarding the **collection year** has been added to the Program Completed (NAT00130) file:
 - For the collection year being reported, Clients with a record in the Program Completed (NAT00030) file must have a corresponding record in the Enrolment (NAT00120) file.

Additional changes

- A Unique Student Identifier (USI) field has been added to the Client (NAT00080) file. This field is currently a placeholder as the legislative changes required for implementation have not yet been finalised. The USI is to be a randomly-generated alpha-numeric code that will stay with the individual student for life and be reported with any nationally recognised VET training undertaken by the student. - Client Usual Residential Address Information has been added to the Client (NAT00080) file & Client Postal Details (NAT00085) file. The Client Usual Residential Address information is the address at which a client usually resides, rather than the temporary address a client relocates to for the purpose of training, work or other. The new address fields found in both the NAT00080 and NAT00085 files are:
 - Address Building / Property Name; Address Flat / Unit Details; Address Street Number; Address Street Name
- New field for the Client Postal Details (NAT00085) file only: Address Postal Delivery Box.



- This AVETMISS release also allows for the capacity to collect skill set information. A skill set can be either a single unit of competency or combinations of units which link to a license or regulatory requirement, or defined industry need. The Standard has been modified to enable the capture of skill set enrolments and completions. Skill set data will be collected in the Program, Enrolment and Program completed files. Skill sets will be identified by two new Program recognition identifiers:
 - 'Nationally recognised skill set specified in a national training package' code = 13.
 - *'Locally recognised skills set'* code = 16.





Specific changes within each NAT file

NAT00010 Training organisation

Training Organisation Type Identifier: The code '23' used to identify: School - Australian Technical Colleges - has been removed.

NAT00020 Training organisation delivery location

Remove Statistical Local Area Field.

NAT00030 Program

No change to the file structure, however, the file will include Skill Sets. As this file will contain courses, qualifications and skill sets, the name of the file has been changed to NAT00030 *Program* file.

In the classification that refers to the level of education for a qualification, two levels have been removed.

- Graduate Diploma
- Graduate Certificate.

NAT00060 Subject

No change to the file structure, however, the file name has been renamed to NAT00060 *Subject* file.

NAT00080 Client

Unique Student Identifier: the identifier to be issued to clients undertaking accredited training only – PLACEHOLDER.

State Identifier: this must be the client's usual residential state. Please refer to State identifier list within the standard. Overseas location will use '99'.

Address Building/Property Name: is the first line of an address where the client usually resides permanently if applicable – field may be blank.

Address Flat/Unit Details: is the second line of an address where the client usually resides permanently if applicable – field may be blank.

Address Street Number: is the third line of an address where the client usually resides permanently – this field must NOT be blank.

Address Street Name: is the fourth line of an address where the client usually resides permanently – this field must NOT be blank.



NAT00085 Client postal details

Address Building/Property Name: is the first line of an address where the client usually resides permanently if applicable – field may be blank.

Address Flat/Unit Details: is the second line of an address where the client usually resides permanently if applicable – field may be blank.

Address Street Number: is the third line of an address where the client usually resides permanently – this field must NOT be blank.

Address Street Name: is the fourth line of an address where the client usually resides permanently – this field must NOT be blank.

Address Postal Delivery Box: where Post Office Box details exist, but must NOT be used in place of the clients' usual residential address.

NAT00090 Client disability

No change.

NAT00100 Client prior educational achievement

No change.

NAT00120 Enrolment

Field *Specific Funding Identifier* has been moved up in the file structure for national reporting purposes.

A new field *Associated Course Identifier* has been introduced in the file structure. This field applies to skill sets only, for reporting the associated Training Package code, where it exists.

NAT00130 Program completed

In line with the change of name for the NAT0030 file to Program, the related file NAT00130 has been renamed to *Program Completed* file.



Specific changes pertaining to Education and Training Reforms for the Future (ETRF)

Under ETRF, additional client/enrolment based data elements are required to be reported, for school students undertaking VET, to assist in the management and maintenance of client records held by the Queensland Studies Authority (QSA).

The additional elements are:

- Learner Unique Identifier (LUI): Under the Employment and Training Reforms for the Future legislation (ETRF), RTO's are required to submit training activity data for all 15-17 year olds, irrespective of funding, and include a LUI in the submission. The LUI is issued by the QSA when a student is registered in year 10 from 2006 onwards. The LUI has been included in the Client file. Please see the file layout for the NAT00080 Client file.
- **Full Time learning option:** Indicates the type of attendance applicable to the qualification/course enrolment being undertaken. The values to be used are 'Y' or 'N'. The value is assigned by the training organisation. Please see the file layout for the NAT00120 Enrolment file.

Proposed definition for the Unique Student I dentifier (USI)

Definitional attributes

DEFINITION

The Unique student identifier distinguishes an individual who accesses Vocational Education and Training (VET) over his or her lifetime.

CONTEXT

The Unique student identifier protects the individual's privacy, allows collation of an individual's educational attainments, and enables government research and analysis.

Relational attributes

RULES

The Unique student identifier is assigned by the Unique Student Identifier Agency/Register as a means of uniquely identifying the client for record-keeping purposes.

Where a client has already been issued a Unique student identifier a training organisation must not request a new Unique student identifier.

The Unique student identifier must be alphanumeric, include both upper and lower case characters, and must include a check digit without a leading zero. The last digit is an automatically generated check digit.

The Unique student identifier differentiates between potentially confusing characters/numbers such as number 1 and letter 'l'.

GUIDELINES FOR USE

Records should be checked to ensure that two or more records with different Unique student identifiers do not identify the same person.
